## Marion Technical College Academic Suspension Appeal

**Policy**: Students are placed on Academic Suspension after three consecutive terms of not meeting minimal academic standing requirements (2.0 GPA). While on Academic Suspension, students are not permitted to enroll in classes for a minimum of one semester, not including summer session (e.g. must take one full 16-week semester off, either fall or spring). If students have unique extenuating circumstances, they may submit an appeal to be reinstated under Continuing Academic Probation Status. See College Policy AP563 (Academic Standing) for more information.

**Instructions:** Students who wish to submit an appeal must complete and submit the following documents. Appeals should be submitted to the Advising and Disability Services Office (Bryson Hall 176) or by emailing <u>advising@mtc.edu</u> from their MTC email. Once all materials are received, the Appeals Committee will review the documentation provided and make a decision. Students will be notified of the decision in writing by MTC email no later than the first week of the semester.

- 1. Complete the form below.
- 2. Write a statement of appeal on a separate piece of paper (please type), addressing the following questions:
  - a. Describe the circumstances that led to your suspension over the previous three semesters. Provide as much detail as possible; the more the Appeals Committee knows about your situation, the better they will be able to make an informed decision.
  - b. During your warning and probation semesters, what steps did you take to improve your performance? If your appeal is approved, what do you plan to do differently this semester to ensure you will be successful?
  - c. What are your long-term goals? How will continuing your degree at MTC help you reach those goals?
- 3. Provide any documentation related to the circumstances of the appeal (for example, medical records, court documents, financial/employment records, etc.).
