IRAC Method for Essays

Familiarity with the IRAC method (Issue, Rule, Application, Conclusion) is highly recommended for organizing your essay responses. IRAC helps you clearly identify the legal

issue, explain the rule, apply it to a scenario, and draw a logical conclusion. This structure mirrors how business leaders analyze legal risks and make strategic decisions.

True/False Prep Tips

- Know when a contract can be voided or enforced (e.g., minors, fraud, mistake).
- Understand when oral agreements are valid or require writing under the Statute of Frauds.
- Be familiar with UCC concepts like risk of loss and buyer/seller remedies.
- Learn the distinctions between business roles and relationships (agent vs. contractor).
- Recognize key legal terms and what makes a statement false or misleading.

Essay Response Preparation

Practice writing short IRAC-based responses using the following prompts:

- 1. Explain actual vs. constructive fraud with a business example.
- 2. Identify which contracts require writing under the UCC and why.
- 3. Describe buyer remedies under the UCC for nonconforming goods.
- 4. Differentiate between agents, employees, and independent contractors.
- 5. Define and apply the elements of negligence and strict liability in business settings.

Focus on demonstrating how legal knowledge can help businesses operate ethically, avoid liability, and comply with regulatory standards.
